- Exposing injustices, disrupting harmful practices


 Critical researchers "may have social and political advocacy responsibilities that extend beyond the individual rights of research participants. Social science researchers, as agents of social change, have a moral responsibility to explore, describe, and theorise about the nature and function of organisations. This is a responsibility that may entail exposing practices and injustices for a greater social good that extends beyond the narrow selfinterests of the institutions being studied."





## SIMM research as a moral project, with goals of emancipation and social justice

"But I wonder why they waited so long. This isn't new. I just presented my testimonial, but in 2014 Geoff Baker published a book where he described the structures at El Sistema that allow the abuse, and concrete cases he collected in his interviews. Baker's book was read, in Venezuela and abroad, as an attack against El Sistema. But at that moment I was being abused in the institution. If they would have taken action then, I would have been protected, as well as other people."
